**If the hirer is in any doubt as to the meaning of the following,  
Please ask or contact a Completely Bounced representative before signing this contract.**

Once you have read this form please sign and date it to signify you acknowledge and accept these terms and conditions and give to a Completely Bounced representative on the day of hire. Duplicate copies are available on the day of hire.

**THE HIRER** (who must be over 18) during the period of hiring will be responsible for the supervision of all the equipment, its care and safety from damage however minor. All inflatable equipment must remain inflated at all times and should never be unplugged or switched off unless you have been instructed to do so by a Completely Bounced representative.

Please ensure no persons interfere with or touch any r.c.d plugs provided by ourselves at any time during the hire period.

The hirer must supervise and authorise all activities at all times, stopping any play liable to cause injury to others or themselves.

Do not reposition the inflatable once a Completely Bounced representative has set it up, doing so will invalidate any insurance.

Always ensure the inflatable is not over crowded, limit numbers according to the age and size, avoid mixing persons of different sizes. If in any doubt please do not hesitate to ask.

There is to be no climbing on the walls of any inflatable, due to the risk of users falling and injuring themselves.

Under no circumstance should any persons be at the rear of the inflatable due to use of electrical equipment.

No one must be on the inflatable during inflation or deflation or if it is raining.

When the surface area including mats becomes wet you must discontinue activities and towel dry all surfaces before allowing activities to continue.

The hirer shall not sub hire or allow the equipment to be used for any unlawful purpose.

The hirer shall be deemed to have inspected the equipment at the time of set up and has agreed that Completely Bounced has supplied the equipment in good condition, with no visual defects. Therefore unless any faults are brought to the attention of Completely Bounced at the completion of assembly, you as the hirer are responsible for any damage caused during the period of your hire and will be liable for all repair costs.

Do not use hosepipes or any water devices including water guns or fairy liquid on any inflatable.

No BBQ's or naked flames, fireworks or sharp objects should be near the inflatable.

No shoes, food, drink, chewing gum or sweets on the inflatable.

No face paints, party poppers, coloured streamers or silly string to be used on or near the inflatable, this permanently stains and you will be charged for damage and cleaning costs.

**PUBLIC LIABILITY INSURANCE** Completely Bounced is protected by five million pound public liability insurance from any civil claim against defective equipment or improper installation. It is important that you understand this does not cover you or any of your guests if an accident occurs under the correct operating conditions or anyone's conduct is proven to be outside of the terms and conditions. The insurance is excluded in its entirety following any claim or injury to any third party or employee whether directly or indirectly related to the use of drugs or alcohol.

**ACCIDENTS** All accidents no matter how minor must be reported to a Completely Bounced representative and recorded in a accident book. If there were witnesses to the accident their statements must be added in to the book.

**DISCLAIMER** Any persons using our equipment do so at their own risk. Completely Bounced has the right to cancel at any time.

**DECLARATION** I declare that I have read and understood the above terms and conditions of hire and any relevant safety instructions supplied with the equipment. I confirm that all the details are correct and I have a duplicate copy of this form. I sign this agreement aware of the implications and responsibilities placed on me by doing so.
